SUBMISSION OF FULL PAPERS

Both abstracts and full papers will be written in Spanish and sent to the Scientific Committee: convencioneventocientifico@cgc.mincin.cu

Requirements for the submission of abstracts and full papers:

- Abstracts will be written in Spanish and must include: title, author (s), institution, city, country, not exceeding 250 words and with Arial-12 font. The deadline for receiving abstracts is March 15th, 2024, and they must be sent to the email address convencioneventocientifico@cgc.mincin.cu
- Full papers must not exceed 15 pages and have the following structure: Title Page, Contents, Abstract, Introduction, Body, Conclusions, Bibliographic References, and

Annexes. The word processor will be 6.0 or 95 (or higher) versions Word, justified text, Arial-12 font, 1.5 space between lines, 2.5-cm margins each side.

c) The title page must include the title of the paper, author's full name, degrees, scientific category, institution, address, city and country of origin, phones and e-mails.

d) Images, charts, tables, graphics, and others must be inserted on Word document. It must not exceed 1 MB. In case this document is higher than 300 Kbytes, it must be compressed by using WinZip 8.1 (or lower) or WinRAR 3.0 (or lower).

e) In the case of videos, a brief description of the content, duration, and format must be included.

f) The deadline for submitting full papers to the Scientific Committee will be April 2nd, 2024.

PRESENTATION IN ELECTRONIC POSTERS (E-POSTER)

The content of the e-Poster must correspond to the work previously submitted to the Scientific Committee for approval regarding title, authors, institution, city, country, and email of the principal author.

They can be displayed sequentially on one or multiple screens, placed in high-traffic areas, so that they are visible to all attendees and extensively discussed, although each author will formally present and defend their e-Poster as planned in the program.

The creation of e-Posters must meet the following requirements:

- Only ten (10) slides corresponding to the headings will be allowed: title and authors, Introduction, materials and methods, results, and conclusions.
- Vertical orientation.
- Dimensions: 27 cm wide by 36 cm long (10.6 x 14.2 in).
- Microsoft Office PowerPoint program is preferably used for their creation.
- The selected font type must ensure easy readability. A minimum size of 20 points is suggested. Italics and bold can be used to highlight elements.
- The images in the e-Poster must have good resolution. When placing images, ensure the relationship between their dimensions and the rest of the e-Poster. Images with lower resolution should always be smaller.
- Graphics: verify the font size used for graph legends.
- Do not use PowerPoint effects or animations.
- Do not use link updates to insert images.
