Member of the European Parliament urges the EU to strengthen actions against US blockade to Cuba



MEP from Spain, Mr. Javier Moreno, urged the European Union to strengthen actions against the blockade imposed by the United States to Cuba, intensified during the health crisis generated by the pandemic of Coronavirus SARS-CoV-2.

The president of the Group of Friendship and Solidarity with Cuba at the European Parliament's 9th Legislative session underlined on his Tweeter account that "In the midst of the Covid-19 pandemic, the EU must strive to put an end to the blockade and the suffocation towards Cuba".

With this declaration, Mr. Moreno complemented a declaration issued by the group to denounce the economic, commercial and financial siege imposed by Washington to the island, qualified in the text as a flagrant, systematic and massive violation of Human Rights.

MEP Javier Moreno also specified: "As members of the Group of Friendship and Solidarity with Cuba, we raise our voices against this blockade that has been in place for over six decades, and it's responsible for incalculable humanitarian damages".

The declaration, previously circulated amongst the MEPs, emphasizes that sanctions imposed to Cuba by the United States are the main obstacle to economic development of the Caribbean country. The text also specifies that they affect dialogs and cooperation and prevents from actually knowing the Cuban reality.

To illustrate the impact of this measures, the parliamentarians cited the example of a recent virtual forum with the President of the Commission for Health and Sports at the Cuban Parliament, Ms. Estela Cristina Luna and members of the Cuban medical brigade that participated on the campaign against Covid-19 in Italy. The meeting was supposed to be held through the online platform Webex, but regulations derived from the blockade impeached the exchange on the current situation of the pandemic in Cub a.

MEPs of the Groupe of Friendship and Solidarity with Cuba reaffirmed their call to put an end to the blockade and called upon the EU "to denounce this criminal policy and to promote dialog, cooperation, political transparency and mutual understanding".

New campaign in Belgium to reject blockade imposed to Cuba



"The campaign "Oxygen for Cuba" shows the rejection of Belgian citizens to the U.S blockade against the United States blockade to Cuba" – declared Wym Leysens, one of the promoters of the initiative, after having listened to the testimonies of some of the victims of this policy.

The representative of the Belgian Coordination against the blockade to Cuba, a movement responsible for the launching of this campaign by the end of April, underlined as well that the feelings of the Belgians go from compassion and solidarity to repudiation.

Oxygen for Cuba gives voice to the inhabitants of the Caribbean island through videos in which they talk about lived experiences under the economic, commercial and financial siege imposed to the island for over 60 years, and intensified, even during this pandemic of Covid-19, by the current U.S Administration.

"The website https://noalbloqueo.be/ already gathers over 100 messages, a number that could seem poor. However, we must consider it is not a signing petition but a space to express your opinion, which demands a higher commitment" — explained Leysens.

According to the activist of solidarity with Cuba, although this campaign can already be considered successful, it will continue until celebration of the General Assembly of the United Nations vote for the resolution presented by Cuba, on the necessity to put an end to the American blockade.

Furthermore, Leysens stated that this campaign shows recognition to the Caribbean island, for its solidarity with other nations when fighting the pandemic of Covid-19, even when the United States deepen the sanctions.

"Cuba is setting a world example of solidarity"- he underlined.

Through testimonies, Cuban citizens shared with the audience the hard experiences of living under a permanent siege:

"For me, the Blockade leads to difficulties with public transportation, troubles to buy food and other supplies or materials to work. The blockade keeps us in constant uncertainty."

"If stores are empty, it's not our fault, the government of the United States is".

Commemoration of the Independence of Venezuela in Brussels



In front of the statue of Simón Bolívar, El Libertador, located at the intersection of the Avenues F.D Roosevelt and Venzuela, members of different solidarity and political organizations as well as those of the diplomatic corps accredited to Belgium gathered to commemorate the 209th Anniversary of the Independence of the Bolivarian Republic of Venezuela.

The Cuban delegation to this important celebration for the American Continent was presided by HE. Ms. Norma Goicochea Estenoz, Ambassador of the Republic of Cuba.

After the wreath-laying ceremony, the Ambassador of the Republic of Venezuela, Ms. Claudia Salerno Caldera affirmed that despite all the aggressions endured by the Homeland of Chávez and Bolívar, the Venezuelan people will raise in victory. Ambassador Salerno also stated that Venezuela will follow the example of the Cuban Revolution, whose resistance for over 60 years has been a source of inspiration.

Following the signature of the Act of Independence of Venezuela, on July 5th, 1811, several nations of the continent declared their Independence, after years of intense fighting in which Simón Bolívar played a key role.
