IMPORTANT NOTES:

1. When applying for a new passport, an **additional amount of 3,500.00 JMD** must be paid to cover the delivery of the passport from the regional distribution centre to Jamaica.
2. For the legalization and certification of documents issued abroad, if the original document is in English, the translation into Spanish must be legalized and charged separately. We are not allowed to legalize only the original document in English, or the translation into Spanish.
3. When any procedure is requested for by postal mail or another person comes to request a migratory service, an extra amount of **4,500.00 JMD** is charged for **“non-personal processing”**.
4. When a procedure is requested for by postal mail, payment must be made by a cheque certified by the bank (manager’s check), in favour of the Embassy of Cuba in Jamaica. Sending cash by mail is not allowed. In the case of **application for a new passport**, payment for the **passport** and the **“non-personal processing”** must be made by a check, and the **additional amount** stated in **NOTE 1** by another separate check.
