**VISA FEE IS £19.00** per green tourist card. In the pink card case **VISA FEE IS £49.00**

If the application is by courier or on behalf of another person: **VISA FEE GREEN TOURIST CARD IS £43.00. VISA FEE PINK TOURIST CARD IS £73.00.**

**Cash only accepted until further notice.**

A Tourist Card is valid only for one entry and for a 90-day stay in Cuba, extendable in Cuba for another 90 days maximum.

**Once a tourist card has been issued it cannot be changed or refunded.**

### WHEN APPLYING YOU MUST SUBMIT:

- Completed and signed application form.
- It is a requirement to complete your data on the site: <https://visasonline.cubaminrex.cu/en>  
**Please, note that this site is only for completing the required information and you cannot process the Tourist card application through this way.**
- Flight Confirmation (inbound & outbound) and Accommodation details.
- Full payment. **(Cash only accepted until further notice. Payment must be made directly at the consulate or through a third party. Regardless of the above, the applicant may use the postal service to send documents. Cash is not allowed to be sent by post. The embassy can't be held responsible for the loss of any document.)**
- Photocopy of the main page of your passport (the passport must be valid for 6 months at

the time of travel to Cuba). We advise you to contact the Embassy before the application is submitted as the visa process might be different and additional documents may be required.

### **IMPORTANT: TRAVELING TO CUBA THROUGH FROM USA**

1. Due to the laws and regulations of the US economic and commercial blockade against Cuba, the US migration authorities do not allow you, regardless of your nationality, to travel to Cuba through or from the USA with the Cuban Tourist Card (Visa) issued in your country of origin.
2. According to those regulations, people travelling to Cuba through or from the USA must fill in a form (affidavit) declaring the reason of your travel to Cuba under the 12 categories approved by the US Government which permits its citizens to travel to Cuba.
3. After filling in the form you will be able to purchase the Cuban Tourist Card (Visa) called Pink Card from a travel agency or at an airport of the USA, which is only sold in the USA and allows you to travel to Cuba through from the USA.
4. The Cuban Tourist Card (Visa) issued in our Consulates is valid for flying to Cuba directly from any country of the world, but through or from the USA, according to its regulations.
5. We recommend you to visit [www.gov.uk/foreign-travel-advice/cuba/entry-requirements](http://www.gov.uk/foreign-travel-advice/cuba/entry-requirements) and to contact your travel agency, tour operator or airline before travelling to Cuba through or from the USA.
